## **EVBA RULES OF ORDER**

**The following rules of order shall apply to meetings of the Association:**

**Every Sitting shall be opened and closed with prayer.**

**Persons invited to a seat may speak on all subjects under debate, but vote on none.**

**No person shall speak more than twice on any motion, unless by permission of the body.**

**All motions carried or not shall be recorded in the minutes.**

**The governance of the body and the regulation of its proceedings shall be strictly in accordance with parliamentary usage so called.**

**That the question be now put is not debatable and if resolved by a two-thirds affirmative vote, the pending question shall be put forthwith without debate and if the first mentioned motion is defeated, the debate on the pending questions shall continue until otherwise ended.**

**That there be a three (3) minute time limit for each speaker.**

**That there be 42 minutes for each issue under debate unless permission for extension is granted by the body on motion approved by a two-thirds affirmative vote. The motion to extend is not debatable.**

**That items be given to the Association Moderator at least 24 hours before presentation for debate.**

**Immediately after the opening of the Association assembly, these rules shall be read distinctly from the Chair.**

### **May 3, 2013 EVBA Minutes**

The spring Association Meetings were held at the Aylesford Baptist Church. Shortly after 9 a.m. the Moderator, Dr. Allison Trites, gave a welcome to those who had assembled in the sanctuary. He then extended an invitation for the Worship Team from Aylesford Baptist Church to lead the singing of songs and a hymn.

Dr. Trites invited the host pastor, Rev. Clyde Lowe, to bring a welcome and share hospitality information. Included in his remarks was an invitation to join him during the mid-morning break for a walk into the new church facility which is under construction adjacent to the current building.

Dr. Anna Robbins, the Associate Professor of Theology, Culture and Ethics, the Director of the Doctor of Ministry Degree Program, and the Academic Dean at Acadia Divinity College, was

introduced by Dr. Trites who invited her to present her keynote address entitled, “‘Spot the difference?’ Working Together as Christians in a Diverse Culture.”

Anna shared the experience of shopping for a birthday card with her four year old son who discovered a very attractive card which he encouraged his mother to buy. She mentioned to her son that the number “60” on the front of the card meant was for a person who was old. “Oh,” he said, “That would be good for Daddy!” Having captured the attention of those assembled she challenged each to take a moment to think of things that were different. This led to her observation that today it is common for differences to be emphasized. She noted that Baptists get caught up on differences. Furthermore, it is common for culture to reject big stories. Consequently the big story of God, of Jesus, of the Holy Spirit is largely rejected.

We live in a technological age with rapidly developing and changing means of communication which has resulted in a change in our understanding of authority and freedom. Furthermore, instant access to a wealth of information (e.g. Google, Wikipedia, etc.) has given us many facts to manage; however, knowledge comes with understanding the facts and knowing which are authoritative and which are not. Much contemporary communication is public (e.g. Tweet, etc.) and we are challenged to distinguish between public and private. For many, faith has become privatized; therefore, we hesitate to speak of Christ publicly. Furthermore, we are strongly influenced by our consumer society where we have many choices which lead to the conviction that you are the center of the universe. We are conditioned to be consumers.

Anna challenged those present to recognize that we have much in common thanks to God’s creative art. As created beings we relate to God, to others, and to creation in Christ. We discover the joy of Christ. We can be the best story tellers. We would be wise to engage the services of key younger leaders who can create online “hubs and spokes.” “And remember,” she said, “Christ brings us together.” Anna concluded her theme with a prayer in which she gave thanks to God for the unity we have in Christ; for the opportunity we have to be Christ’s people; and for the mission we have to love people in the name of Christ.

Dr. Trites expressed thanks to Dr. Robins; and went on to thank Rev. John Beers for the service he renders as a communicator of Association information and news via email.

The offering was received, and then there was a refreshment break.

When the folk reassembled they were numbered off with Group 1 meeting with Greg Cox, Group 2 meeting with Bob McKay, and Group 3 meeting with Sarah McIntyre Stevens to brainstorm over three questions: 1. What is the purpose of the Association? 2. How do you see Association serving your church? 3. What do you want from Association? After forty-five minutes the groups reassembled in the sanctuary for a plenary reporting session. The notes from that session were turned over to the Clerk to be used by the Executive for future planning and discussion.

The Moderator then began the EVBA Business Session which included the following items:

1. Rev. Dan Jamer, after explaining that Rev. Dennis Leamont, the Clerk who prepared the 2012 Fall Association Minutes, is dealing with brain cancer, moved that the November 10, 2012 Minutes, which had been slipped into each Association Report Book, be approved with the corrected year (i.e. 2012 instead of 2013). Dr. Marc Potvin seconded the motion which was PASSED.
2. Points from the Moderator's Report (p. 7) were shared by Dr. Allison Trites.
3. Rev. Dan Jamer presented the Leadership Training Day (March 3, 2013) Report (p. 8) and concluded by inviting all present to mark Saturday, March 1, 2014, in their 2014 Planner so that they could attend the 2014 Leadership Conference at the Berwick Baptist Church when the theme will be "Building Relationships in the Church."  
Dr. Trites expressed thanks to Dan for his involvement in the EVBA; announced that Dan has accepted a call to be the Pastor at Union Street Baptist Church in Saint Stephen, NB; and then offered prayer on behalf of Marion and Dan Jamer.
4. The Moderator invited Sandra Ward to the platform. She explained that at the February 16<sup>th</sup> combined meeting of the EVBA Mission Day Planning Committee and the EVBA Mission Committee it was duly passed that "the EVBA Council be asked to explore combining the Association Mission Day with the regular sessions of the EVBA." The motion was made by Sandra Ward, seconded by Rev. John Beers and PASSED.
5. Rev. Elizabeth Johnson presented the Chaplaincy Committee Report (p. 9). She expressed appreciation for the continuing ministry of Rev. Debra Mosher at Dykeland Lodge in Windsor and the beginning of Rev. Sarah Scott's ministry at Grandview Manor in Berwick. The Dykeland Chaplaincy now receives financial support from the interest generated by the Rev. Don Ehler Memorial Chaplaincy Fund, and the Rev. Dr. Dennis Veinotte Memorial Chaplaincy Fund has passed the \$7,000 mark of the \$50,000 goal. Once that goal is achieved the interest generated will help support our Chaplain at Grandview Manor. Elizabeth appealed for two people to volunteer to join the Chaplaincy Committee which meets monthly at ADC.  
Rev. Hedley Hopkins asked about Rev. Debra Mosher's ministry at the Windsor Elms Village in Falmouth. Elizabeth explained that Debra has a separate contract with the Elms which does not involve EVBA.  
Sheila Macdonald appealed for volunteers to be at Grandview Manor on Sunday afternoons to help move residents to the Worship Service.
6. Lic. Greg Cox presented the Evangelism/Social Action Committee Report (p. 9). Two meetings have been held since these committees amalgamated. He noted that Social Action brings world issues to the churches while Evangelism takes the Gospel to the world. Rev. Jennifer Smart is a resource person for matters relating to mental health. Rev. Dan Jamer attended the recent "Mental Health First Aid Training" event.
7. Rev. Dr. Peter Lohnes presented the Leadership Development Committee Report (p. 10). He reminded those in attendance that the annual Pastors and Church Leaders Conference will be on Saturday, March 1, 2014. He then listed those who have met with the LDC and have been recommended to the EVBA for the following recognition:

- a. Renew An Association License to Minister – Michael Shaw (Bethany Memorial), and Chad Clements (Morristown).
- b. Grant An Association License to Minister for the First Time – Tara Albert (Berwick), Greg Cox (First Cornwallis), Sarah McIntyre Stevens (Bethany Memorial), and James Smith (Coldbrook).
- c. Grant An Association Lay License to Minister for the First Time – Linda Davidson (Centreville), and Mary Perkins (Berwick).

At the conclusion of the Association Session the Moderator and the Clerk signed those of the above documents that were available to be signed.

8. Bob McKay presented the Mission Committee Report (p. 11). Two Ministry Initiative Grants were awarded in 2012 by the Atlantic Baptist Mission Board of the Convention of Atlantic Baptist Churches on recommendation of the EVBA Mission Committee. The Mission Committee was also involved in formulating the motion made earlier by Sandra Ward.
9. In the absence of the Chairman, Vincent Leung, Laurie Hennigar directed the people's attention to the Kingswood Camp Board Report (pp. 12-13) and highlighted several points in the report and encouraged those present to be sure to claim the Kingswood Camp 2013 material which has been put in envelopes addressed to each church in the EVBA. Effective May 1, 2013 Nikki Metcalfe was named Executive Director, succeeding her predecessor Kathie Cox. Laurie then gave an informative overview of the Financial Report of Kingswood Camp Society for 2012 (pp. 13-15) when receipts totaled \$203,354 and expenses totaled \$187,763.69 leaving a year-end balance of \$15,590.31. However, Laurie pointed out that although Kingswood Camp is a mission of the Association Churches, and an important ministry for children and youth who are meeting Christ, there is a disturbing decline in financial support on the part of Association Churches and people within these churches. He challenged those present not only to support the camp financially, but also to "encourage kids to come to camp." "Remember," he said, "we are going forward. We're excited! Therefore, pray for our program, our staff and our campers."
10. Robert Douglas presented the Treasurer's Report (pp. 16-20). He presented highlights and explanations relating to the report, and then moved that the Report be accepted. Rev. Clyde Lowe seconded the motion, and by vote it was PASSED.  
The Moderator expressed thanks to Bob for his continuing services.
11. Rev. Dan Jamer presented the Nominating Committee Report (pp. 21-23). Dan explained that in light of his departure from the EVBA Wayne Marriott has agreed to serve as the "Past Moderator;" Rev. Ron Baxter has agreed to serve as Clerk; Rev. Rob Heffernan has joined the Leadership Development Committee; two nominees are needed for the Chaplaincy Committee; the name of Lic. Devon Rogers is to be deleted from the Kingswood Camp Committee and Kingswood Camp Trustees; and one nominee is needed for the Nominating Committee. It was duly moved by Rev. Dan Jamer, seconded by Marshall Jones and PASSED that the Nominating Committee Report be accepted.  
Rev. John Beers suggested that the names of nominees be given to any member of the Nominating Committee.  
Rev. Dan Jamer made the observation that the one year term for persons serving as Moderator passes so quickly that one is just learning how to function when the term is over. Therefore, Rev. Dan Jamer presented the following motion: "Effective with the elections at

the November 2013 meeting of the EVBA that the term be changed from one year to two years for the Vice Moderator, the Moderator and the Past Moderator. The motion was seconded by Bob Douglas and PASSED by the Delegates.

Rev. Dan Jamer made some concluding comments relating to people being a positive force in the EVBA. He presented his version of a famous quote when he said, “Ask not what my Association can do for me. Ask what I can do for my Association.”

12. Dr. Peter Lohnes came to the platform to remind those assembled that from August 3 – 10, 2013 Tidal Impact will bring upwards of 350 young people to our Annapolis Valley to work with upwards of 15 Baptist churches to carry out morning ministries,
13. participate in a massive food drive in cooperation with Feed Nova Scotia, enjoy fun times, and participate in three evening Valley Rallies at New Minas Baptist Church, and will conclude with the Great Public Rally at the Apple Dome in Berwick on Friday, August 9<sup>th</sup>, at 6:30 p.m. which will include not only Tidal Impact youth and leaders, but also delegates from the annual assembly of the Convention of Atlantic Baptist Churches and you if you choose to attend.
14. Dr. Allison Trites offered a closing prayer and grace for the lunch which was being provided by the members of the Aylesford Baptist Church. The EVBA adjourned at 11:50 a.m.

**At the September 7<sup>th</sup> Association Council Meeting a motion was passed stating that the November 9, 2013 Association be a full-day event with the EVBA planning the morning session and the EVBWomen and the Mission Committee planning the afternoon session. ## **Stewardship Committee**

**The committee has had two meetings during the year but has had numerous email meetings to review financial updates as well as dealing with issues relating to salary, benefits etc. for new Chaplaincy staff at Grandview Manor. As a result of these discussions Stewardship and the Chaplaincy committee meet with management of Grandview and arranged for a \$2,800 increase in their financial support to the Association.**

**At our initial meeting it was suggested that we must request Council to resurrect a previously formed committee to re-look at what we really want the Association to be in the present day, to something which will be meaningful to our contributing churches. This is suggested as a result of declining financial support from our churches. In the interim our Committee will try to obtain email addresses of Treasurers of our churches in an effort to communicate with them and encourage financial support from those not already contributing.**

**During this past month we met to review the 2014 Budget which suggests that we will have an \$8,500 shortfall, which is primarily as a result of decreased church giving's and a return to our previous \$5,000 donation to Kingswood Camp. While the budget is included in the Association report it will be the recommendation of our Committee that the budget be tabled to our May Association meeting. With actual yearend results we can prepare a more meaningful and accurate budget. This can be prepared by Stewardship in January, presented to Council for review in February and onto Association in May.**

## **Kingswood Camp Report, 2013**

**To the Eastern Valley and the Annapolis Digby Baptist Associations.**

**It is with praise and Thanksgiving that I prepare this report to the Associations on behalf of the Board of Directors, Kingswood Camp Society. We praise and Thank God for His blessings on our camping ministry this year. We are also thankful to the many individuals in our Associations who have worked tirelessly and have given generously their time and resources to support this ministry. Among them are the Executive Director, Nikki Metcalfe, the Board Treasurer, Laurie Hennigar, the Camp staff team, the Board members and the many donors and volunteers who together weave a beautiful tapestry that is Kingswood Camp under the Lordship of Jesus Christ.**

**The summer camp registration totalling 282 this year showing a small increase (6) over 2012 in the number of paid campers. Following are a number of interesting observations about the campers this year:**

- 1. 60% of the campers are in some way connected to the churches and a total of 44 churches of various denominations are represented.**
- 2. 40 % of the campers came to camp as a result of the efforts of our Outreach programs.**
- 3. 42 of 154 ( 27%) of the church related campers came from the Annapolis-Digby Baptist Association**
- 4. 58% of the campers (160) were returnees; 114 came to camp for the first time.**

**We have had very positive feedbacks from the campers, parents and camp staff of their experiences at camp this summer. A number of the parents remarked on the positive changes they noticed in their children after camp.**

**As a service to the schools Nikki and the senior staff team have been offering day camps to the children of primary and junior high schools in June. This service has become an effective way of recruiting campers. This year nine schools participated bringing a total of 509 students. 25 of them came to our summer camps.**

**Kingswood Camp has also decided to make the camp available on weekends in the month of June for Church Youth Groups and Church Retreats. If you are interested in using the camp facilities for these purposes please contact Nikki for further details.**

**During the months of September to May of the following year, the camp is available for rental to churches and other Christian groups.**

**A total of 16 rentals are anticipated for 2013. We hope that more of our church groups would plan to use Kingswood Camp in their programs. Please refer to our web-site for details.**

**The program and personnel sub-committee of the Camp Board worked diligently to recruit, interview and train camp staff for the ministry of the campers. Similarly the maintenance sub-committee members are dedicated to ensuring that the facilities are in good working condition. The Board, in response to the evident need to provide an indoor activities facility to enhance the camping ministry year round has established a building sub-committee to make plans for the construction of a recreation building. We are thankful that the Louis Millett Grant money will be a substantial help in this endeavour. We realize, however, that many volunteer workers and donations are needed in the coming days to make the recreation building a reality. We welcome your support in any form. Please contact any members of the Kingswood Camp Board to indicate your interest in this project.**

**All Council Members came forward, as a united group, while a statement was read from them regarding a recommendation last year that CABC accept the ASBE as one of our**

**Convention Ministry Partners. Although they “hold to the perspective of Biblical Equality might distract them from healthy, more important conversations that are needed. of men and women, which includes both men and women exercising their gifts of ministry and leadership, no all of our constituents agree.” Therefore, they decided, at this time, not to pursue this recommendation until further study and dialogue, in non-threatening environments, be held to explore scripture together. They felt at this time that focusing on this recommendation**

**There were 28 changes to the General Operating By-Law of CABC because of the change from Letters Patent under the Canadian Corporations Act TO Articles of Continuance under the Canada Not-For-Profit Corporations Act. This was passed with one motion, with the places written out in the Book of Business. A special meeting can now be called by 5% of the members instead of 20%. We can no longer use “ex officio” members but can appoint up to less than 1/3 of the total directors, to join as members.**

**Under the proposed United in Mission budget for 2014 there is an increase of 4.22% from the 2013 budget. There are 3 new Ministers and support staff this coming year, and we met Cheryl Ann Beals, Minister of Clergy Formation & and Health and Paul Carline, Minister or Intercultural Ministries.**

**Friday night I was so excited to be able to Worship with the Youth of CAB Churches in Berwick. It was so great to be part of an Inter-generational time of Worship to our Lord! It was so awesome to see so many, over 20!**

**I was able to attend the session about the Black history in Nova Scotia, the AUBA, and was encouraged by learning how the Lord has worked in the lives of these brothers and sisters. History was never something I was interested in until I started to understand more about my Lord and the history of how He has worked in and through so many as written in His Word!**

**It was great to hear about the new Church plant New Brunswick as well as what is happening at River Cross. The Hope Mission is staying on Main street, when the body of believers moves to their new location to worship and share God’s Word.**

**Ministry essentials are: to Impact Leaders, Infuse Culture and Ignite Mission!**

## Oasis 2013 Report

### Friday, Aug. 9<sup>th</sup>

Anna Robins brought a devotional entitled, “Did God REALLY Say?” It came from Genesis 3:1-5. She begins by saying that the plan of the serpent is to plant doubt into Adam and Eve’s mind. “This is the seed that is planted into contemporary society. We continue to ask the question...Did God really say?” Her first point was that Jesus is “the way, the truth, and the life”. She went on to discuss how there are many different religions but that Jesus did tell us that He is the truth – there are no other paths to God except through Him. But we continue to question... “Did God really say that?”

Dr. Robins’ second point was that we continue to question whether Jesus said there is “no Jew or Greek, slave nor free, male or female” in Christ and that we are all equal and one in Him. Even though the word of God says this there are still people who question if God really said this in His word. Anna’s third point of the devotional was from Matthew 16:18. She commented on the scripture that nothing will be able to stop the building of Christ’s church, not even the gates of hell. Anna asked us all what the Spirit is saying to us and our churches... to not exclude even one person from the church. She ended it by saying, “If the gospel isn’t for everyone, it’s for no one.”

### Family Business

- Reverend Michael Palmer is the new Vice President (p.5)
- Report from Crandall University by Bruce Fawcett: printed 165,000 copies of the Crandall news paper
- ASBE is not being partnered with at this time by the Baptist Convention even though there are many who support the cause (p 10)
- Amendments to the General Operating Bylaw no longer have the wording “letters patented” but “Articles”. Instead of “Ex-officio” they now say “appointed members”.
- 20% of member churches were able to call a “special meeting” at one time but now this number has been reduced to only 5% of member churches are able to call a “special meeting”

Bruce Fawcett brought the afternoon devotional which was entitled: “Showing Love When You Don’t Feel Like It.” The overall message here was to teach scripture with compassion, cultivate kindness, build relationships, and to be prepared for criticism and misunderstandings. In ministry there will always be people that are “hard to love” but it is important to ask for God’s help and to keep on trying to love them just as Christ loves us.

### Saturday, Aug. 10<sup>th</sup>

Seminar: Building Youth Ministries That Effectively Grow Disciples, Dale Stairs

We looked at two research projects overlapping: 1. Hemorrhaging Faith and 2. Dale’s own

**personal findings. First, in the Hemorrhaging faith study nearly 3000 18-34 year olds from all provinces and territories completed the survey. 72 young adults were interviewed. The purpose of this was to find out why they decided to leave the church and why others decided to stay. 7 in 10 (70%) of children who grew up in the church will leave by the time they are young adults.**

**Things that pushed the youth away:**

- **Not given responsibility within churches and if they were given it it was without any help “sink or swim” kind of mentality**
- **Judgemental attitudes and strict rules about behaviour – there was no conversation around the rules “just obey them and that’s it”**
- **Superficial teaching (they want more than topical teaching/preaching)**
- **Not experiencing God**

**Things that keep youth connected:**

- **Significant mentors (or adults who invested in them)**
- **Mission Experiences (i.e. tidal Impact)**
- **Christian camp**
- **Friends who are involved in church**
- **Spiritually engaged parents**
- **Vibrant church community (people that cared about them, knew what sports or instruments they played and would ask about their week etc.)**

**Study 2. Dale Stair’s own research and findings**

**Dale looked at the time period from the end of WWII until 2010.**

**Thing that are not effective:**

**Concerts, excessive fun events, unfocused sports ministries, and hang-out based ministries without relationships being made.**

**Significant Discipleship Practices:**

**Mentoring, missions and service opportunity, small group Bible study and prayer, and camp attendance and leadership.**

**From WWII-2010 and even today we see the things that have worked and the things that have not. Some still reign true for today; the overlap between the two studies was:**

- **Relationships/Mentoring**
- **Camp Ministry**
- **Mission and Service Projects**

**The overall conclusion was that mentoring, intentional relationships and time invested into our young people is essential.**

**Exec. Minister Dr. Peter Reid “Mission Ignite”, Rally #1**

**The gospel always involves word and deed**

**The mission is to set people free from systemic sin as well as individual sin.**

**Three Ministry Leaders: Impact leaders, Infuse culture, and Ignite mission**

**The worst reason for amalgamation of churches is for survival - it should be about mission**

**CBM Presentation: Tim and Diane Bannister - Had to step out for work**

**Dr. Lennett Anderson “Raised Expectations”, Luke 14**

- **Its time for the salt to come out of the shaker**
- **We are called to be light of the world**
- **In order for there to be a divine intervention the church needs to work together**
- **Lets embrace the human race, there has to be unity in the community**
- **I know we like playing church but lets be the church**
- **There is more unity in the community then in the body and we want to infuse culture? Culture could teach us a few things**
- **Christianity is a verb not a noun**
- **We will be surprised who will show up at the table if its an open invitation**
- **Jesus was on a mission: everybody on the outside, Jesus brought on the inside**
- **We weren't the first invitation but we got a second one, to save wretches like us!**
- **God wants his seats filled – just like a restaurant wants their seats filled and a hotel wants their rooms filled, so does God want his table full**
- **Places like this will shut down if there aren't enough people**
- **We don't get to say who comes to the Father's house – there's an invitation to ALL people**
- **True Christianity is not exclusive but inclusive**
- **Found people find people – there is still room at the table**

**These points are notes I took of Dr. Lennett Anderson's message. Most are direct quotes from him and his main point for the message. God wants us to get up and out of our churches and our comfort zones and to seek out those who are lost and not yet found. God wants us to invite ALL people – including those who are different from us to eat at the table.**

**Common Theme for Oasis 2013**

**If I had to choose a common theme for Oasis 2013 it would be that we need to bring people in and make the gospel relevant for the 21<sup>st</sup> century. Not to change the message but to make it appropriate for all people in all places.**

**Unfortunately I was not able to be at the events on Sunday as I am the Associate and Youth pastor at Bethany Memorial Baptist Church and had a youth service planned for that Sunday.**
